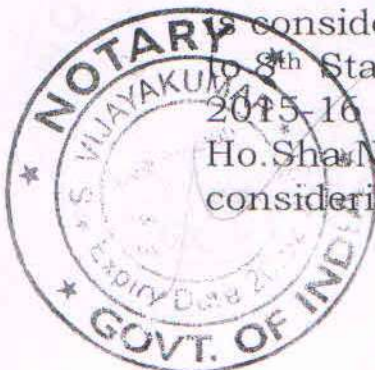

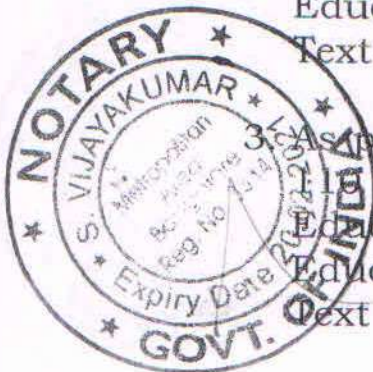

**Terms and Conditions :**

1. Should follow Rules framed under Karnataka Education Act, 1983, Karnataka Act 1 of 1995 and as per the Circulars circulated by the Government and by the Department from time to time and strictly follow the Orders.
2. Should provide Safety of the School and Essential Amenities as per the Rules 4, 5, 6 and 8 of the Government Notification No.116 ViViDha 95 dated 14.11.95 vide Rules framed under Karnataka Educational Institutions, Classification, Control and Text Book Evaluation Rules, 1995.

3. As per Rule 10 of the Government Notification No. ED 116 ViViDha 95 dated 14.11.95 as per the Karnataka Educational Act, 1983, and as per Karnataka Educational Institutions, Classification, Control and Text Book Evaluation of the Karnataka Act 1 of 1995



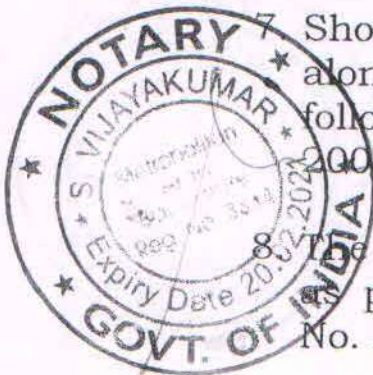


the Term Fee, Tuition Fee, Special Developmental Fee should be collected. And it should be in accordance with Rule 19(4).

4. The School should be run in the Medium permitted and in the said place only as per Section 41(5) of the Karnataka Educational Act, 1983. There is no provision to change of place and transfer of the School for the period of 5 years from the date of sanction. If intended to change the place/transfer of the School after completion of the stipulated period, then the newly registration, sanction / permission may be obtained.
5. As per the Serial Number 9, 1957 Rule 13 of the Karnataka State Societies Registration Act, 21, 1960 the Accounts of the Institution may be submitted to the Registrar of Societies upto the previous year. And also obtain approval of the Executive Committee Members List and obtain Acknowledgement and the Acknowledgement and List of Approval may be submitted to this Office with 30 days party in person.
6. As per the Circular as per Government Notification ED 131 ViViDha 98 of the Educational Act, 1983 dated 04.11.99, the Recognition Rules 1999 as per Rule 3 Sub Rule 2 and as per Circular of the Director, Higher Education, the Institution may be deposit the amounts in Fixed Deposits vide Circular No. C8(4)(7) SASHiAa Ni Aa 01/02-03 dated 13.12.02 in the Joint name of the Secretary of the Executive Committee and the notified Authorised Authority and the same may be renewed from time to time.

7. Should submit all the documents as per the Check List along with information and this rules should strictly followed as per the Government Order No. ED 44 S L B 2007 dated 03.09.2007 and its Annex at 3.

8. The Accounts, Documents of the School may be kept per the directions in the Government Notification No. ED 74 ViViDha 2004 Bangalore Dated 14.08.2006.





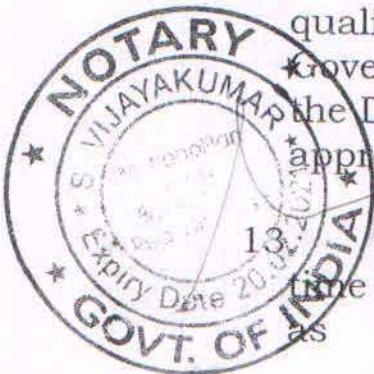
9. Should follow the linguistic Rules as per the government Order No. ED 28 PGC 1994, Bangalore dated 29.04.1994, Government Circular No. ED 165 PGC 2004 dated 03.01.2005, Circular of the Hon'ble Commissioner vide No. C7(7)PraSiAa/Ithare/57/2002-03 dated 12.02.2004 and 10.02.2005 and C7(3)PraSiAa/Nondani-132/2005-05 dated 08.03.2006 and Government Order No. ED 28 PGC 94 Bangalore, dated 29.04.1994 and 30.05.2005, Government Order No. ED 1001 DGO 79 Bangalore dated 07.08.2000 and also the details question paper, students Note Book, Text Books, etc., supportive documents and inspecting the students practically and should follow compulsorily the linguistic Rules and should record the same in their report. If there is any violation of the Government Orders regarding linguistic Rules, the same may be recorded in the Report.

10. The Strength of the Higher Primary School should be minimum 100 and the School should be run continuously from the year 2010-11 as per Rule 4(k) of Government Notification No. ED 131 ViViDha 98 dated 04.11.99 and as Karnataka Educational Institutions Recognition Rules 1999 from the year 2010-11.

11. All the facilities including basic amenities, appoint of Teachers and other facilities should be provided according to the additional Sections as per the Directions of the Government Order No. ED 133 S.E.S. 2005, Bangalore dated 20<sup>th</sup> March 2005.

12. The Approval / Recognition is only valid when the qualified Teachers are appointed as per the Government Order and as per the Rules prescribed by the Department. If violated the same, the recognition / approval may be cancelled.

Should open the Service Records from time to time in each and every teaching and non teaching staff as per Government Notification No. ED.104





S.E.Pe.2005 dated 12.01.2006 and they should be certified.

14. As per the Government Orders the salaries of the Teachers should be paid into their Savings Bank Accounts directly. Should not pay in cash on any reason. Should provide Service Safety to the Teachers and to the Staff of the School as per the Government Order dated 12.01.2006.

15. This Order is in current, if the first approval / recognition and transfers / renewal of approvals from the date of starting of the Institution / School is in order as per the Educational Act. If any of the conditions are violated the recognition stands automatically cancelled.

16. To take steps by the Administrative Board to follow the 09 Points prescribed by the Commissioner of Police, Bangalore City vide its Order No. 157/MAG (1) Others/2014 dated 26.08.2014 in the interest of safety of the School Children and to follow the guidelines.

17. Should take all safety measures as per the Rules and Regulations.

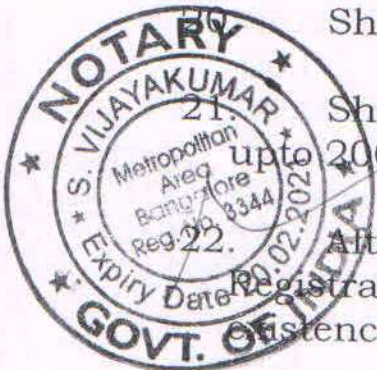
18. The School should be registered under R.T.I. Act.

19. Should not punish the School Students physically.

Should fix fire extinguishes.

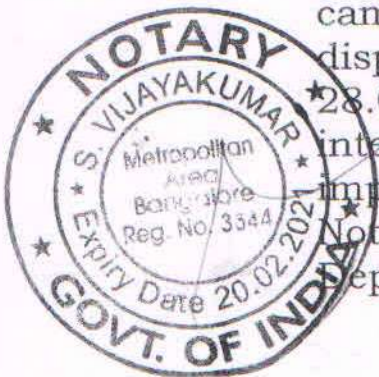
Should display the 'NO SMOKING ZONE' Board upto 200 Mtrs. from the School Premises.

After implementation of Education Act 1983, the Registration is must for the schools which are in existence and they should be registered.





23. The First Recognition should be obtained within 2 months from the date of obtaining School Permission. If the Schools are continued without obtaining first approval, if submitted for subsequent approvals, then this approval is cancelled automatically.
24. In respect of maintenance of School Vehicles should follow the Orders and Directions of the Transport Department.
25. The steps leading to upper floors should not be congested. If in each and every stage the safety walls are not constructed or the walls are so thin and small then take safety measures. Minimum 5 feet partition walls should be construction. And also fix the Grills for inflow of air and light. This Recognition is valid only when all the aforesaid rules are followed, if fail to do so, this Recognition stands cancel automatically.
26. To teach for the students studying at 1<sup>st</sup> to 5<sup>th</sup> Standards, the Teachers should pass Teacher Eligibility Test (TET). (Effect from 09.06.2014). The Administrative should appoint the Teachers who passed the said Examination.
27. The Hon'ble High Court of Karnataka in Writ Petition No. 14363/94 and heard some in some more cased on 02.07.2008 and passed the Orders, and the Government of Karnataka filed S.L.P. 18139-18163 before the Hon'ble Supreme Court of India the same is considered as Civil Appeal 5166-5190 of 2013 are transferred to Constitutional Bench, thereafter on 06.05.2014 passed the Judgement, thereafter on 19.02.2015 the Associated Management filed an appeal came for hearing and finally the Hon'ble Court disposed off the Writ Petition 55106/2014 on 28.04.2015. In the said Order it is directed that the interim order passed on 22.02.2015 should be implemented on or before 20.05.2015 and as per Notification of the Commissioner, Public Education Department dated 10.04.2015 and as per





Memorandum dated 16.05.2015 the Schools registered for Kannada Medium from 1<sup>st</sup> to 5<sup>th</sup> Standard may submit its application for conversion, and the Schools comes under the orders of the Hon'ble Commissioner, the Para (9) of the conditions is not applicable.

Sub:- Amendment in affiliation Bye-laws Rule 3.3(I) chapter II-reg.

Sir/Madam,

Consequent upon recommendations of the Affiliation Committee made in its meeting held on 24.06.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 28.06.2013, the following amendment in affiliation Bye-laws of the Board has been made by the Board:

Existing Rule 3.3 (I) chapter II	Amended Rule 3.3 (I) chapter II
The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T. Govt. Its application either should be forwarded by the State Govt. or there should be a No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with the CBSE. "No Objection Certificate" once issued to any school will be considered at par even if it prescribes a specific period of *stage unless it is withdrawn. Condition of submitting a No Objection Certificate will not be applicable to categories 3.1(i) to (iv)	The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T Govt. and also to produce evidence to this effect that the applicant school had intimated to the concerned Education Department of the State about the application made to CBSE for seeking affiliation with the Board. In case, the Board receives any objection during the process of application of the school, the Board may ask the concerned school to produce the No Objection Certificate from the State Government or otherwise it would be assumed that concerned State/U.T. Government has No objection.

The above amendment is brought to the notice of all concerned.
